

Merrill's Candy Store By Linda Rush Bleam

How did the store come to be named Merrill's? I remember a Tastee Candy store sign, but no one used that designation; it was always Merrill's at 7th & Juniper Streets. My parents, Merrill and Peg (her given name was Marguerite) opened the luncheonette when I was approximately one year old and my brother, Barry, was eight. The "store", as we referred to it, was on the ground floor and our living quarters were on the second floor, which was quite spacious.

Initially the store was open six days a week from 9:00 AM to 10:00 PM and Sunday morning. It was not unusual for a neighbor to ring our doorbell when the store was closed because they needed milk or bread. My parents never complained. Because of the many hours the store was open for business, neighbors that were looking for a friendly place to work and gain some additional household money worked there part-time.

One that I especially remember was Mary Dietz. She was a hard worker and always friendly to everyone. Her children gained recognition in school for their athletic abilities. Another neighbor that worked there was Joy Rantz.

The menu was typical in that hamburgers, hot dogs, steak sandwiches and a variety of other sandwiches were offered along with sodas, milkshakes, ice cream and sundaes. During the summer, when the school children were taking their finals, the "rickies" served in a tall frosted glass were a popular cold drink during the hot weather.

For many years, school students could leave the grounds (of the school) for lunch. This allowed many of the students to come for lunch at Merrill's. Lunchtime was crazy for that short period of the day! Merrill prepared many hamburgers and hot dogs in advance, and early in the morning, before the store opened for business, my mother had prepared all the different flavors of drinks offered in addition to the bottled sodas, one of which was Moxie.

There was a period when I was young, that cokes were made by using 1 squirt of coke syrup for a small soda or 2 squirts for a large soda from the soda fountain behind the counter, with seltzer fizz added. During the winter when the flu was going around neighbors would buy just the coke syrup to ease their stomach discomfort.

My job was to sell the candy bars and penny candies. The ice cream was hand-dipped and the pretzels were sold by the pound from a large tin container. There was a short period when some kids experimented with the wrappers on the straws, dipping them in mustard or ketchup, blowing through the straw and shooting the wrappers to the ceiling where they would stick until my dad had to use a stepladder to clean the ceiling. Needless to say, he put a stop to that entertainment.

Anyone with memories of the store will always comment on the dark, white and milk chocolate candy, with mouthwatering delights of creams, nuts and caramels, along with chocolate covered pretzels. The busiest times were the holidays – Easter, Christmas and Valentine's Day. My dad had many different metal molds of bunnies, eggs, etc.

He outdid himself with his chocolate Easter creations that he began making in January in the basement. He worked until 1:00 AM to prepare for that holiday. People came from a great distance to buy the chocolate candy to give as gifts. Local churches ordered one-pound boxes of mixed chocolates to give to members. All the boxes were packed by hand by family members. My mother would drive to Reading to purchase the large bulk pieces of chocolate my dad melted for the candy. He also made different kinds of nut brittles that were made in a large copper kettle over the stove, then poured onto a thick marble table to cool. When it cooled, he wore gloves and broke it into pieces to be sold by the pound.

One of my memories was of a woman that periodically came into the store for something to eat. She could not pay but my parents would give her food. It seemed to me at the time that she would show up on a somewhat regular basis and my dad spoke to her in Pennsylvania German, which some people called Pennsylvania Dutch. She always wore layers of dark clothing and appeared somewhat unkempt.

I was always frightened of her because I thought she was a witch. No one ever explained her situation to me, but I often wondered what happened to her. Robert Leight wrote a wonderful article about her that answered my questions. My parents always referred to her as Alice.

I am not sure just when my dad stopped talking to some of the customers in Pennsylvania Dutch. I guess it was because the elderly customers no longer frequented the store and the language was dying out. I don't remember my mother speaking the language, but it was my paternal grandparents, Mabel and Mahlon, that spoke the language to each other when they were at home. They ran the restaurant in the Bush House on Broad Street in Quakertown.
